WILL OF DAVID(1)HAYS OF SMITH TWP., WASHINGTON CO., PA.

In the Name of God Amain David Hays of Smith township and County of Washington and State of Pennsylvanis, being indisposed in Body but through the mercey and goodness of God of Sound and well Disposing mind and memory and Calling to mind the uncertanty of this Life do this third Day of April in the year of our Lord one Thousand Seven hundred and Ninety two make and Publish this my last will and Testament in manner and form following, that is to Say:- Imprimis I Commend my Soul into the hands of Almighty God who give it me and my Body to the Earth from whence it came in hopes of a Joyfull Resurrection through the merrits of my Saviour Jesus Christ - Secondly it is my will that all my Just debts and funeral expences be duly payed and Satisfied. I give and bequeath unto my Son Thomas two hundred acres of Land it being part of a tract of Land that I purchased from George McCormick the Sd. two hundred acres is adjoining Lun Washingtons Line (the place where Sd. Thos. now lives)

Itim I give and Bequaith unto my Son Joseph one hundred and forty five acres of Land it Being the place where he now lives the above Land to run along Blakneys Line to it Stricks Lun Washingtons Line then to run Such a corse as will take in the above mentioned quantity -

Item I give and Bequaith unto my Sons William and Andrew two hundred and fifty acres of Land to Be Equally Divided Betwent them the above mentioned Land is to join the before mentioned Thos. and Joseph and to run down the Line on the west Side of the Creek untill it Comes apasst Betwent Sd Wm feild and Moses meadow and to run Betwent the feild and the Meadow untill it Stricks the Draft the Comes Down Betwent Wm and Moses and to follow the SaidDraft to the head and then a corse towards Smith Line as fare as will make the above Compliment it Being the old Improvement and each of the above mentioned Wm and Andrew to live where they now live - Item I give and Bequaith unto my Son David one hundred acres of Land it Being the place where Sd David noe Lives Begining at the Corner of his feild on Philes Line and to follow Sd Line untill it Striks Wm and Andrews Line and then along Wm and Andrews Line So fare as to make up the Compliment

Item I give and Bequaith unto my Son James one hundred and thirty acres of Land it Being the Lowest Improvement that I have on the Creek where Joseph Did Live the Same to Begin at the Corner on the West Side of the Creek on Rankins Line then along Sd Line to it joins Philles then to it joins David then go Back to the Corner on Rankin Line and then Come up the Line on the west Side of the Creek so fare asto run with a stright Line that will Cross the Creek and come up Betwixt Moses Shop and the feild aback of Sd Shop and Extend so far as will take in the Compliment - Item I give and Bequaith unto my Son Moses the Improvement where he now lives with the remainder of all the tract

Item I likewise give and Bequaith unto my Son Thomas fifty pounds of my Personable Estate - Item I give and Bequaith unto my son James the Bond which I lifted for him from Jno. Maxwell - Item I give and Bequaith unto my Daughter Prudence Seventy five pounds of my Personable Estate Likewise my Bed with Beading - Item I give and Bequaith unto my Daughter Elenor Seventy five pounds of my Personable Estate - Item I give and Bequaith unto my Daughter Elizabeth Seventy five pounds of my Personable Estate - Item I give and Bequaith unto my Daughter Mary Seventy five pounds of my Personable Estate - Item I give and Bequaith unto my Daughter Ann Seventy five pounds of my Personable Estate - and if there Should Be any of my Personable Estate Left after the above Sums is paid it is my Desire that it Should Be Equally Divided amongst all my Childeran - I do nominat and appoint my good and trustty friends James Edgar, John Lyle and Thomas Hays to Be hole and Sole Executors of this my Last Will and Testament hereby revocing all former Wills By me made and do Declare this only to be my last Will and Testament

In Witness Whereof I the Said David Hays Senr have hereunto Set my hand and Seal the Day and year first above Written Signed Sealed Published and Declaired By the above Named David Hays Senr for and as his last Will and Testament in the presence of us who have hereunto Subcribed our Names as Witnesses of the Same in his presence and at his Request
